# New Mexico Junior Wrestling, Inc. Policy & Procedures (A non-profit organization)

#### 1.0 Name

1.1 New Mexico Junior Wrestling, Inc. (to be referred to as NMJW, Inc. in official documents).

# 2.0 Purpose

- 2.1 To give all participants an enjoyable, wholesome, rewarding introduction and education to wrestling.
- 2.2 To give all participants an opportunity to develop their physical skills through the medium of wrestling.
- 2.3 To give all participants an opportunity to meet, know and appreciate other boys and girls from diverse physical, ethnic, economic, social and cultural backgrounds.
- 2.4 To give all participants an activity that will develop their character physical well-being and an appreciation for sportsmanship under the guidance of direct adult leadership.
- 2.5 To serve the interest and well-being of all participants.
- 2.6 For every participant in the program to have FUN, have a chance to wrestle and experience the results of competition. Winning is a desired goal, but at this age level it cannot be the most important goal.
- 2.7 Promote good sportsmanship. We desire to create a positive environment based on mutual respect, rather than a "Win-At-All-Cost" attitude. Our programs are designed to instill good sportsmanship among wrestlers, coaches, parents and fans.
- 2.8 Foster a blend of fun and competition.
- 2.9 Expect all those involved with NMJW, Inc; wrestlers, parents, coaches and spectators to abide by, as well as promote and encourage these purposes and philosophies.

## 3.0 Membership

- 3.1 The body of NMJW, Inc is made up of wrestlers and coaches. The head coach from each team will be considered special members and will have voting privileges. Each team will have one vote regardless of board membership. (See Other Roles & Responsibilities 7.0)
- 3.2 Youth wrestling is open to children ages 4-14. Wrestlers shall be 4 years of age prior to September 1 of the upcoming wrestling season.
- 3.3 All divisions are grouped by age according to year of birth (September 1st). (Referred to as participants or wrestlers throughout this document.)
- 3.4 Parents and guardians of all registered wrestlers. (Referred to as general members throughout this document).

#### 4.0 Fees and Insurance

- 4.1 An insurance fee is required each season from each participant at a cost of \$24.00 plus taxes; this fee shall be paid in order to be classified as an NMJW Member. This fee must be paid in order to wrestle in any NMJW sanctioned event. This fee includes AAU Wrestling Membership.
- 4.2 All membership fees must be paid prior to the 1st day of practice.
- 4.3 These fees shall be paid directly to AAU.
- 4.4 NMJW general operating funds shall be used for the State Tournament, the Greater Southwest Nationals Tournament, and specific purchases that directly benefit NMJW wrestlers and NMJW, INC as voted on by special members and/or the Board of Directors.
- 4.5 Wrestlers shall not practice or compete without first purchasing their membership. Refunds for membership fees will not be authorized.

#### 5.0 Tournament Fees

5.1 All regular tournaments, \$23.00 per wrestler per bracket for all registered participants, will have a deadline of Wednesday at 11:59pm MST. Starting Thursday at 12:00am MST, the fee will increase by \$5.00 (before online fees). A \$7.00 fee per entry is due and made payable to NMJW, Inc. prior to the

- start of the tournament. For tournaments with less than 400 participants fees will be reduced to \$5.00 per entry.
- 5.2 Novice Championship, \$25 per NMJW wrestler. A \$12.00 per fee entry is due and made payable to NMJW, Inc. prior to the start of the tournament.
- 5.3 State Tournament, \$43.00 per NMJW wrestler. Only wrestlers who reside in NM are eligible to participate in the State Tournament. NOTE: Any residency issues must be submitted to the NMJW Board by Dec 31st.
- 5.4 Greater Southwest National Tournament, \$58.00 per wrestler per division.
- 5.5 Insurance Claim forms will be made available at every tournament through the Board of Directors.
- 5.6 Registration fees for every wrestler registered for a tournament shall be paid to the hosting team regardless of if they made weight or were no-shows. Any unpaid tournament fees shall be paid prior to participating in any other NMJW Tournaments.

# 6.0 Uniforms/Equipment

NOTE: NMJW follows uniform rules in accordance with NFHS standards.

- 6.1 Each team will determine their uniforms.
- 6.2 Wrestlers shall wear light heelless wrestling shoes, reaching above the ankles. If the laces are visible, then they shall be secured in an acceptable fashion.
- 6.3 Wrestlers shall wear wrestling ear guards, which provide:
  - A. Adequate ear protection.
  - B. No injury hazard to the opponent.
  - C. An adjustable locking device to prevent it from coming off or turning on the wrestler's head.
  - D. Long hair must be covered with appropriate headgear to include built in hair bonnet.
- 6.4 Special equipment is defined as any equipment worn that is not required by rule. Any equipment that does not permit any normal movement of the joints and which prevents one's opponent from applying normal holds shall not be permitted. Any equipment that is hard/abrasive must be covered and padded. Special equipment includes, but is not limited to: Hair coverings, face masks, braces, supports, eye protection, and socks.
- 6.5 Wrestlers wearing shirts under their singlet must comply with the following: shirts must be of compression fit. No loose fit clothing will be allowed to include but not limited to; t-shirts, sweats and/or shorts.
- 6.6 No jewelry of any kind shall be worn during weigh-ins or tournaments.
- 6.7 No Street Shoes will be allowed on the mats.
- 6.8 Fingernails must be kept trimmed.
- 6.9 Each contestant who has braces or has a special orthodontic device on his or her teeth shall be required to wear a tooth and mouth protector. A tooth and/or mouth protector (intraoral) shall include an occlusal (protecting and departing the biting surfaces) and a labial (protecting the teeth and supporting structures) portion and cover the teeth and all areas of the braces or special orthodontic device with adequate thickness. This would include upper and lower teeth if devices are present on both. It is recommended the protector be properly fitted and:
  - A. Constructed from a model made from an impression of the individual's teeth and braces or special orthodontic device.
  - B. Constructed and fitted to the individual by impressing the teeth and braces or special orthodontic device into the tooth and mouth protector itself.
- 7.0 Head Coaches (special members) Requirements and Privileges (Including but not limited to the following) NOTE: All parents and coaches are role models for the wrestlers and shall provide positive representation at all NMJW, Inc. wrestling functions. Coaching our youth is a privilege NOT a right or entitlement.
  - 7.1 Provide input on decisions presented to or by the Board of Directors at the Annual Special Members Meeting.

- 7.2 Ability to bid to host a tournament at the NMJW, Inc. Annual Special Members Meeting.
- 7.3 Represent your team at all NMJW, Inc. meetings or assign an assistant coach as your representative.
- 7.4 Communicate/organize location for practice and tournament facilities.
- 7.5 All coaches MUST have an AAU coaches' card which requires a background check before they can coach.
- 7.6 At least 1 coach from each team MUST be First Aid/CPR certified and attend all practices. NOTE: If a coach is NOT certified and an injury occurs in your care NMJW, Inc. will not be held responsible.
- 7.7 As special members, the head coach will be able to vote for the NMJW board members including the Executive Officers. If the head coach is an NMJW Board member, they will assign their team vote to an Assistant Coach or Team Mom.
- 7.8 Head coaches shall submit a list of coaches for their team that are allowed to obtain NMJW coaches badges.

## 8.0 Coaches Badges

- 8.1 Not all AAU card holders are entitled to a coach's badge. All coaches' badges shall be issued at the discretion of the Board of Directors and be listed on the Head Coaches roster. (See item 7.8)
- 8.2 Each team will be given 5 coaches' badges and an additional badge for every 4 wrestlers after 20.
- 8.3 All NMJW Coaches Badges shall be submitted by DECEMBER 15th. Any badges submitted after the deadline will not be issued.

#### 9.0 Coaching Ethics

- 9.1 Coaches shall not "belittle" or physically abuse wrestlers but may use constructive criticism in private.
- 9.2 Coaches shall not criticize the opposing team, coaches, mat officials or fans in any shape or form.
- 9.3 Coaches shall refrain from using abusive/profane language.
- 9.4 Coaches shall not "Boo", intimidate, or overt criticism of any athlete, parent, official, or board member.
- 9.5 Coaches shall not discriminate against any wrestler under any circumstances.
- 9.6 Coaches shall strive to make every wrestling activity serve as a training ground for life and as a basis for good mental and physical health.
- 9.7 Coaches shall emphasize proper nutrition/diet for proper weight control.
- 9.8 Coaches shall set a good example by following all the rules and regulations of NMJW and wrestling as it pertains to them.
- 9.9 Coaches shall ensure all team members and parents shall promote good sportsmanship at all times.
- 9.10 There shall be a maximum of two coaches per corner for a mat. If a team breaks this rule one team point shall be deducted per violation.
- 9.11 Coaches ejected from a tournament shall assist as a table worker for a minimum of half a tournament with no pay before they will be allowed to coach at another tournament. If a coach gets ejected for a 2nd time during the season, they will need to assist as a table worker for 3 full tournaments with no pay before they will be allowed to coach at another tournament. If a coach gets ejected a 3<sup>rd</sup> time all coaching privileges shall be revoked for the remainder of the current season.

#### 10.0 Tournament Directors

- 10.1 Shall provide a tournament flyer to NMJW two weeks prior to the tournament. Posting tournament flyers on www.newmexicojuniorwrestling.com is strongly encouraged. It is the responsibility of each Tournament Director to properly promote their tournament.
- 10.2 Shall ensure all bracketing is done the night prior to the tournament.
- 10.3 Weight and bracket changes will be at the tournament director's discretion.
- 10.4 Tournament directors shall try to accommodate any participant when a mistake by the hosting team has been made (i.e. wrong weight, wrong division). A refund is not a suitable solution.

- 10.5 Shall be responsible for the delivery and return of equipment from the designated NMJW Representative immediately following the tournament. Completion of the equipment checklist is required.
- 10.6 Shall return all complaint forms to the NMJW, Inc. office or directly to a Board Officer within 3 days of the tournament.
- 10.7 Shall provide their own security and crowd control to maintain a safe environment for all participants and table workers. NOTE: A Tournament Director checklist will be provided by NMJW.
- 10.8 Tournament directors MUST have an Athletic Trainer, EMS, or medical personnel on site before the tournament begins and remain onsite until the event is completed. NO EXCEPTIONS
- 10.9 Tournament admission charge shall not exceed \$10.00 and is permitted at all NMJW Sanctioned Events, not to include the State Tournament and Greater Southwest Nationals.

# 11.0 Parent/Guardian Ethics

- 11.1 Parents must adhere to all policies & procedures and of any facility being used by NMJW, Inc.
- 11.2 Parents must adhere to all NMJW, INC policies and procedures when attending any NMJW, Inc. function.
- 11.3 Parents shall remain in the spectator areas unless you are performing an assigned duty by the tournament Director or Board of Directors. Failure to comply may result in their wrestler being disqualified.
- 11.4 All parents/guardians shall refrain from unsportsmanlike conduct, which includes but is not limited to any or all here-in mentioned and not mentioned.
- 11.5 All parents/guardians shall refrain from using abusive and/or profane language.
- 11.6 All parents/guardians shall abide by the school district policy regarding the possession and/or use of illegal drugs, alcohol on school property.
- 11.7 Parents/guardians shall NOT strike any coach, board member, official, spectator, or participant in the NMJW, Inc. program. If a parent/guardian breaks this rule, it will result in an immediate ban from all remaining NMJW Tournaments of the current season. Further punishment will be at the discretion of the NMJW Board of Directors.
- 11.8 Any comments or concerns by a parent or guardian shall be directed to the Head Coach or the officers of the organization as soon as possible.
- 11.9 All parents/guardians shall adhere to the Albuquerque Public Schools Event Clear Bag Policy.
  - A. The Albuquerque Public School district is implementing a clear-bag policy for all APS athletics events during the 2025-26 school year, starting the week of August 17, 2025. The policy will apply to all APS athletics venues, including stadiums, school fields and gyms. Non-sports events at those sites also will be affected. District personnel and signage will advise spectators coming to APS games that only a clear bag and/or clear clutch will be allowed at stadiums, fields and gyms. Diaper bags also must be clear. If a bag is turned away, it will need to be returned to a guest's vehicle. The new policy does not apply to student athletes who have district-issued team bags and are participating during the event.
    - 1. The clear bag policy is modeled after industry standards, which allow for the following:
      - a. Bags that are clear, plastic, vinyl or PVC.
      - b. A one-gallon clear plastic zipper-style freezer bag
    - 2. Prohibited items include, but are not limited to:
      - a. Purses that are not clear
      - b. Coolers
      - c. Briefcases
      - d. Backpacks
      - e. Drawstring bags
      - f. Luggage of any kind (includes wagons)
      - g. Computer bags

B. Farmington, Rio Rancho, Las Cruces and Los Lunas also have their own bag policies. The policy will extend to middle school athletic events as well.

## 12.0 Wrestler Ethics / Code of Conduct

NOTE: A wrestler can and will be dismissed from the NMJW, Inc. organization for any legitimized reasons:

- 12.1 Misconduct, which includes, but is not limited to:
  - A. Biting, fighting, bullying, name calling, abusive language, spitting, intentional/flagrant injury to other wrestlers.
  - B. Possession, use, or distribution of any illegal substance with the exception of a legally obtained drug prescription.
  - C. Use or possession of marijuana, tobacco, alcohol, or electronic cigarettes (e-cigs).
  - D. Vandalism of any and all property, including practice and tournament facilities as well as hotels/motels.
  - E. Poor sportsmanship
- 12.2 A wrestler can be withheld from participating as a representative of the organization for any of the above reasons and/or any of the following:
  - A. Disrespect to any wrestler, coach, referee, or board member.
  - B. Having a communicable disease (at the discretion of mat officials or of the NMJW Board of Directors) This list of misconducts is not all inclusive. Other incidents shall and will be dealt with as they arise, by the head coach, mat officials and/or board members.
- 12.3 Written documentation of any misconduct will be submitted to and handled by the Executive Board of NMJW

## 13.0 Officials: Appointments/Qualifications/Compensations

- 13.1 Attacking or harassing an official will not be tolerated and could result in civil and/or criminal charges. NMJW, Inc. actions could include event attendance suspension and/or removal of coaching privileges.
- 13.2 The Board of Directors shall appoint a Head Official annually. An appointment will be made before the annual "Special Members (coaches)" meeting.
- 13.3 Officials shall attend required training to acquire certification.
- 13.4 The Head Official shall be paid at a rate of \$250.00 per 8 hours; certified officials shall be paid at a rate of \$225.00 per 8 hours; uncertified officials shall be paid at a rate of \$125.00 per 8 hours.

  Tournament's lasting in excess of 8 hours, Officials will shall be compensated at a rate of \$30 per hour. Greater Southwest Nationals is excluded from this fee and will be negotiated with officials prior to the tournament.
- 13.5 One official shall get an additional \$25 per tournament to cover all the extra duties such as handing out and collecting gear, running a clinic before all events to youth officials, collecting payment from tournament host, and paying out the officials for the event. This fee shall be covered by the host team.
- 13.6 Each head official shall also give a brief clinic with questions and answers to youth officials before each event.
- 13.7 Travel costs shall be paid for by the hosting team.
  - A. Mileage fees shall only be paid towards 2 officials max and the other official can choose to drive alone for no mileage fee. Mileage fees shall be paid based on the following mileages: 51-100 MILES = \$40 101-150 MILES = \$50 151-200 MILES \$60 201-250 MILES = \$70 251-300 = \$80
- 13.8 NMJW Board of Directors shall appoint two assignors each season, one for the northern region and one for the southern region.
  - A. Northern Region shall be defined as any area from Belen northward.
  - B. Southern Region shall be defined as any area from Socorro southward.
- 13.9 NMJW will pay out the assignor fee of \$25 per tournament to the assignor who delegated the

assignments of officials for those tournaments. This fee shall be paid at the end of the season.

- 13.10 As part of the assignor duties this shall include:
  - A. Provide a minimum of 2 Certified NMAA officials at every event.
  - B. There shall be one Certified NMAA official for every 4 mats
  - C. Schedule all High School Athlete referees to serve as an official on the day of the tournament from the local area
  - D. There shall be 5 officials for every 4 mats with a ratio of 1 Certified NMAA official per every 4 youth officials.
- 13.11 Age Requirement: 18 years of age for Certified Officials with prior wrestling knowledge and 16 years of age for Junior Officials with prior wrestling knowledge (use discretion).
- 13.12 A minimum of One Head Official who is certified will be present at every NMJW scheduled tournament.
- 13.13 Officials are required to perform duties around officiating in an unbiased manner.
- 13.14 Officials are required to control their mat and discipline coaches, wrestlers, or parents as per the National Federation of High Schools (NFHS) rulebook.
- 13.15 Officials shall determine if disciplinary measures are needed to control their mat. Once an official has made a disciplinary decision, they must immediately inform the Tournament Director, Head Official and a NMJW Board Member (If present).
- 13.16 A Board Member/Tournament Director cannot overturn an official's ruling on the mat.
- 13.17 Officials will use National Federation of High Schools (NFHS) rules.
- 13.18 Officials are required to ensure the safety of all participants.

# 14.0 Special Member Meetings (not limited to the following)

- 14.1 Season Kickoff Meeting
  - A. Held before the Folkstyle season starts.
  - B. Review new policies and changes for the upcoming season.
  - C. Provide preview of upcoming season schedule.
  - D. Provide head coaches (special members) the opportunity to bid on weekends to host tournaments. NOTE: The Board of Directors makes the final determination on the tournament schedule. Teams may be excluded based on past tournament performances and any outstanding debt owed to NMJW or any vendor associated with the NMJW.
  - E. Hold elections for any vacant board positions if they exist.
- 14.2 End of Season Meeting
  - A. Held after the Folkstyle season.
  - B. Review Policies and Procedures and discuss ways to improve.
  - C. Elect new Officers and Board Members for the upcoming season.
  - D. Organize New Mexico teams for National events.
  - E. Plan upcoming Freestyle/Greco season.

#### 15.0 Tournaments

- 15.1 All tournaments shall be bid on at the beginning of the season by each team and approved by the NMJW Board of Directors. Tournament bids will be ranked using a scoring system.
- 15.2 The Board of Directors shall award each tournament when multiple teams have bid on the tournament or weekend.
- 15.3 Any tournament director may include a separate event dedicated to either a novice or takedown tournament. Novice and takedown tournaments shall include both a boys and girls division and shall follow the same age and weight groups as defined in section 15.7.
  - A. Any wrestler who registers for a novice tournament and does not meet the criteria as defined in section 15.4 shall be removed from the tournament and entry fee shall be forfeited.
- 15.4 A novice wrestler shall be defined as an individual who has wrestled less than two seasons.

- 15.5 The tournament director, for all regular tournaments, shall be the head coach from the team hosting the tournament, unless another is appointed by the head coach.
- 15.6 All wrestlers shall be current AAU members before they are able to compete.
- 15.6 All westlers shall be current AAO members before they are able to compete.

  15.7 All regular season tournaments will have the following divisions/weights (excluding GSWN)

  Note: HWT's must be called in at their actual (registered) weight. If a wrestler is over their
- 15.8 At the discretion of the tournament director of a given tournament, wrestlers may be allowed to double bracket in ONE of two ways, if it is offered. Either in two separate divisions or in the same division at two separate weights. Either way is limited to two entries per wrestler per tournament. If a wrestler chooses to double bracket, they forfeit the requirement for a "rest" period in between matches. For instance, if the wrestler is up at the same time on two different mats, a 2 Skip Rule will apply meaning 2 matches will be skipped to accommodate until the wrestler is complete with the match that started first. If they do not report by the 2nd skip, then they will be forfeited. Rest time could possibly be zero minutes. By choosing to double bracket, wrestlers, parents, and coaches agree to this period of potential zero rest. This is necessary to make sure tournaments move along in a timely manner.

designated weight limit, the wrestler can be moved up a division or have a new division created, at

- 15.9 There will be a weight allowance of a 1lb growth allowance after January 1st.
- 15.10 Time period for divisions is as follows: 6 and 8 and under will be 1, 1, 1. 10, 12 and 14 under will be 1.5, 1.5, 1.5 HS Boys and Girls will be 2, 2, 2. All consolation matches will be 1, 1, 1.
- 15.11 Following NFHS rules a Technical Fall will be called when a wrestler obtains a 15-point lead.
- 15.12 If the tournament director cannot resolve a conflict pertaining to the tournament, a member of the Board of Directors shall be notified. The final judgment will be made by the members of the Board of Directors. All board members present at the tournament shall be notified of the conflict for a resolution between members. All attempts will be made to resolve the conflict as soon as possible. Board recommendation for resolution will be binding.
- 15.13 All tournaments shall have a Girls and High School Division which will be split up by age.
- 15.14 No two clubs/teams shall combine after December 31<sup>st</sup> of that given season. If a situation does develop where a club/team closes operations a request must be submitted in writing and brought before the NMJW Board of Directors for approval. Any club/team that combines after the deadline shall be disbarred from team scoring at all NMJW sponsored events for the remainder of the season.

#### 16.0 Weigh-ins

- 16.1 All teams are required to use calibrated scales. The tournament director will coordinate the weigh-in times for the tournament. All wrestlers shall be weighed in.
- 16.2 NMJW will no longer offer "home weigh-ins".

the discretion of the Tournament Director.

16.3 Satellite weigh-ins can be set up for non-qualifying tournaments with the Tournament Director's

direction. Weigh-ins shall take place no earlier than 24 hours before the start of the tournament and no later than 12 hours before the start of the tournament.

- A. Satellite weigh-ins **MUST** be hosted by a board member.
- 16.4 All weights shall be scratch weight. If a wrestler does not make their registered weight, they may be scratched from that bracket without a refund. The Tournament Director can allow a wrestler to move up to the next weight if an empty bracket slot is available and time permits. The decision is solely the Tournament Director's decision. Tournament Director is able to charge up to \$10.00 per wrestler.
- 16.5 If a wrestler makes his/her registered weight, the weight and division will be marked on the wrestler's arm. State and Greater Southwest Nationals are excluded.
- 16.6 A skin and fingernail check shall be conducted at every tournament during weigh-ins.
- 16.7 Wrestlers shall be required to wear a complete (singlet or bottom AND top) NFHS approved uniforms at weigh-ins.
- 16.8 Wrestlers shall provide a doctor's release for any questionable skin irritations. The release must be completed on the required "NMJW Physician Release Form".
- 16.9 Wrestlers shall wear Headgear at all NMJW sanctioned events except at GSWN.
- 16.10 Wrestlers must be ready to start on time.
  - Note: Hosting tournament teams may not weigh-in prior to other teams. This gives them an unfair advantage and will not be tolerated. If this occurs that team will be subject to disciplinary sanctions as determined by the Board of Directors.
- 16.11 National Federation of High Schools (NFHS) rules will be used. The tournament director may supplement these rules but must do it in writing, for approval by the Board and Head Official, one week prior to when the tournament flyers are distributed. Note: If non-certified officials are used and an injury occurs NMJW, INC will not be held liable.
- 16.12 The match shall not begin unless there is a certified coach for each wrestler present (unless the wrestlers are from the same team).
- 16.13 Only certified coaches will be allowed on the wrestling floor.
- 16.14 The number of coaches allowed on the floor will not be limited but they shall be active team coaches and listed on the team roster.

#### 17.0 Novice Championship

- 17.1 Host team will host a Novice Tournament Championship and provide the following:
  - A. Security
  - B. Set up and clean up
  - C. Arranging Table workers
  - D. Team Trophies (1st, 2nd, 3rd)
  - E. Provide certified officials
  - F. Receiving rosters and bracketing
  - G. Staffing for Weigh-ins
- 17.2 New Mexico Junior Wrestling, Inc. will provide the following:
  - A. Individual Awards (1st –4th)
- 17.3 A novice wrestler shall be defined as an individual who has wrestled less than two seasons.

#### 18.0 STATE

- 18.1 New Mexico Junior Wrestling, Inc. will host the annual State Tournament and provide the following:
  - A. Security
  - B. Set up and clean up
  - C. Arranging Table workers
  - D. Team Trophies (1st, 2nd, 3rd)
  - E. Individual Awards (1st -6th)

- F. Provide certified officials
- G. Receiving rosters and bracketing
- H. Staffing for Weigh-ins
- 18.2 Qualifications to participate in the NMJW State Tournament are as follows:
  - A. Be a resident of New Mexico.
  - B. All wrestlers must have wrestled in 3 out of metro designated State Qualifying Tournaments.
  - C. Wrestlers will not be allowed to wrestle at any weight lower than what they wrestled at any of the qualifiers.
  - D. Wrestlers shall not be allowed to wrestle at any age division other than what they qualified at.
  - E. If a wrestler does not make weight, they will be eliminated from the tournament. No rebracketing and no refunds at State. Wrestlers must have wrestled at least one NMJW sanctioned tournament at that weight.

# 18.3 State Seeding

A. State seeding shall be draw them in with a true second at state

#### 18.4 Team Scoring

A. Team Scoring: The top 15 wrestlers from each team with the most team points scored on Trackwrestling will be counted in the final team points as calculated by Trackwrestling.

#### 19.0 Greater Southwest National Tournament

- 19.1 NMJW, INC will host and provide the following:
  - A. Security
  - B. Set up and clean up.
  - C. Arranging Table workers.
  - D. Team Trophies (1st, 2nd, 3rd).
  - E. Individual Awards (1st -6th).
  - F. Provide Certified Officials.
  - G. Receiving rosters and bracketing
  - H. Staffing for Weigh-ins
- 19.2 All tournament fees shall be made to NMJW, INC.
- 19.3 Admission will be charged and will be staffed by NMJW, with all proceeds going to NMJW, INC.
- 19.4 There will be challenge matches. (3rd may challenge for 2nd ONLY if they had not previously wrestled in this tournament).
- 19.5 Team Scoring
  - A. Team Scoring: The top 15 wrestlers from each team with the most team points scored on Trackwrestling will be counted in the final team points as calculated by Trackwrestling.

## 20.0 Discipline/Standing Rules

- 20.1 The penalty for violations of NMJW, Inc and NFHS rules will be imposed as follows:
- 20.2 Acts of Disbarment: A coach or other adult acting in an official capacity may be barred from further participation in the NMJW organization or any of its affiliates by violating any of the following rules or committing any of the following acts/violations; but not limited to:
  - A. Striking any coach, official, spectator, participant, or board member in the NMJW program
  - B. For any sufficient cause, such as unsportsmanlike conduct, unethical behavior, or profane language, whether on the mat, as a spectator, or in any official capacity.
  - C. Acts of Dismissal: A parent/guardian may be dismissed and their child's/children's membership with the organization and any of its affiliates terminated by violation of any of the above noted acts. The determination of this dismissal shall be approved by a majority vote of the NMJW board of directors.
  - D. Written documentation of any disciplinary action will be submitted to and handled by NMJW board of directors. Official's disciplinary decisions will be upheld in accordance with NFHS rules

and guidelines.

- 20.3 Authority Nothing herein prohibits the organization from taking immediate action on a violation if the officers of the organization decide this action is in the best interest of the organization. Any member of NMJW that has been dropped from the team or barred from any event of the organization has the right to have such action reviewed and a chance to present his/her case to the board of NMJW, then to be voted upon by the board of the NMJW, Inc. organization to either uphold official action taken or overrule such action. Any action passed by the board of the NMJW; Inc. organization will be the final word. All decisions made by the board of directors of the NMJW, Inc. organization are binding upon all individuals.
- 20.4 Code of Conduct Individuals such as wrestlers, coaches, parents and other supporters who participate in events sanctioned through New Mexico Junior Wrestling, Inc. (NMJW) including tournaments or practices, or events sanctioned by other States or national governing bodies, in which NMJW participates, are required to subscribe and conform to the following code of conduct. Failure to conform to this code of conduct may result in disciplinary action. Other more specific codes of conduct may be provided by NMJW for specific classes of participants, such as competitors, coaches or parents. Failure to conform to participant specific codes of conduct may also result in disciplinary action and include the same rights to due process.
- 20.5 Any individual who accepts and bears responsibility for one or more athletes at an event shall at all times act in a manner consistent with the preservation of the safety and well-being of those athletes in his or her care. This includes, but is not limited to coaches, officials, parents and team leaders.
- 20.6 Any individual who attends an event will at all times act in a manner consistent with the preservation of the safety and well-being of other athletes and volunteers or paid participants.
- 20.7 Any conflicts or disputes concerning the setup or conduct of competition, practices, training camps or other events are to be settled without resorting to acts of verbal or physical threats or violence, or the use of abusive, obscene or vulgar language.
- 20.8 Any individual who attends an event will observe and conform to the laws and customs of the State, Country and institution where the event is conducted.
- 20.9 Any individual involved in the setup or conduct of an event will at all times act in a manner which promotes the growth and well-being of the sport of wrestling.
- 20.10 Drugs and Alcohol use will not be tolerated during or prior to events sanctioned by NMJW. If a parent, coach, or wrestler is suspected of being under the influence at an event, the safety of the children will be of utmost concern. Any wrestler, coach, or parent who witnesses or suspects such a violation is obligated to report their suspicions to the authorities and to contact a member of the NMJW Board. Any person under the influence of drugs or alcohol at an event will be subject to immediate dismissal from the event in addition to further disciplinary action.
- 20.11 Sexual Harassment will not be tolerated by parents, coaches, or wrestlers. Any wrestler, coach, or parent who witnesses or suspects such a violation is obligated to report their suspicions to the authorities and to contact a member of the NMJW Board. Any person committing sexual harassment will be subject to further disciplinary action.
- 20.12 Disciplinary action includes but is not limited to the following:
  - A. Warnings
    - 1. Written/verbal warnings will be at the discretion of NMJW.
    - 2. (Reserved for Changes)
  - B. Probation
    - 1. Probation may be issued longer than one season.
    - 2. (Reserved for Changes)
  - C. Suspension
    - 1. Suspension may be of any length of time and may include sanctions against participation at events sanctioned by NMJW.
    - 2. Nothing herein prohibits the NMJW Board of Directors from taking immediate suspension

- action on a violation if the officers of the organization decide this action is in the best interest of NMJW. The suspension can be up to two seasons.
- 3. Refunds will not be given for AAU Wrestling membership fees, tournament entries, coaching fees, etc., if disciplinary action results in Suspension. Note: The status of any individual at any capacity with NMJW, Inc., will be reviewed prior to the upcoming season for final determination and final status with the NMJW organization.
- 20.13 Due Process All individuals are presumed innocent of wrongdoing until there is a reasonable body of evidence to the contrary. Minimum due process concerns any disciplinary action, which affects an individual's participation in a single practice or event.
  - A. The individual must be given a statement of the specific violation, which shall be in a written format.
  - B. Notice must be given of what disciplinary action will be imposed.
  - C. The accused must have the opportunity to comment on the disciplinary action.
  - D. The accused has the right to appeal the decision to the NMJW Board of Directors.
- 20.14 Maximum due process concerns any disciplinary action, which affects an individual's participation in more than one practice or event. Written notice of a disciplinary hearing shall be provided to the accused. The notice will include the place and time of the hearing. This notice will also include a statement of the specific violation, which if deemed accurate by the NMJW Board, would justify disciplinary action. The hearing will be conducted by a minimum of three members of the NMJW Board of Directors (the number of members will remain an odd number to prevent a tie). No one involved in the specific violation leading to disciplinary action shall be involved with conducting the hearing. The hearing decision will be formed by a majority vote. The hearing shall be an adversarial hearing. The accused shall be permitted to present evidence and witnesses, and examine the evidence and witnesses presented against him or her. Any admission of guilt shall constitute a sufficient body of evidence to justify disciplinary action. In the event that the findings of the hearing committee are averse to the accused, the accused shall have the right to appeal the decision at the next regularly scheduled meeting of the NMJW Board. At the request of the accused, or the President of NMJW, the appeal may be made before an appeal board appointed by the NMJW Board, at a time and/or place other than the regularly scheduled board meeting. Administration fees accrued during this due process hearing will be forwarded to the accused if deemed necessary.
